# After the Wonca Europe 2015 Conference in Istanbul, October 22-25, 2015 – the organiser's perspective

It has been always a privilege to host any WONCA Europe activity or meeting for both the host country and organizing committee. As the president of WONCA 2015 İstanbul Conference, I was the lucky one. At the beginning of the almost 5 year journey, I was young, brave, enthusiastic and naive (Picture 1). As the time went by, work schedule for WONCA Conference changed from once a week to every day. Skype meetings, phone calls, e-mail; they all needed a special skill to manage. Every detail, various requests, different needs should be handled carefully, rigorously and in time. But succeeding a high quality conference both scientifically and socially was the most important concern for all of us. That was the time which had driven me a little crazy (Picture 2).

On the other hand we had a lot of fun during this journey. We get closer with friends from Turkey and all around the World. We found out the richness and creativity of family medicine society as well as their willingness to help and participate. We recognized the value of our organization and its networks and special interest groups. But at most we had a chance to test our creativeness.

At the end, we have hosted 3800 friends from different countries; almost thirty percent of them being young doctors. Although it was a European conference, among the 79 countries people have participated from, 40 of those were non-European. 190 young doctors participated in VdGM Conference. Istanbul conference was the first time all young leaders of WONCA got together.

1692 abstract were presented; 13 courses, 121 workshops, 8 panels, 30 symposiums, 10 conferences and 18 BRITE sessions took place. Program was run with 19 parallel sessions.

### There were some of the things which were new for WONCA Europe conferences.

**HostPro-ISt 2015** was a chance for "family physicians who stays young" to investigate health care system in Turkey and visit different places of host country before the conference.

**Grand sessions** were invented to give a chance to audience to hear more about the experts' opinions and experiences on hot and important topics.

Vice versa **BRITEs** were planned to give a chance to practicing GPs to speak and share their opinion and experiences with the audience and get feedback.

**Opening Panel** was another "first time" experience which was just before the opening ceremony.

#### *It was hard times in Turkey, as well as the whole Europe and unfortunately it still is.* Warfare, violence and migration; occurring as a result of each other was the atmosphere of 2015

conference. But it did not stop our willingness to make this conference real and did not stop family physicians to participate.

### Epilogue;

Now I am settled down. Sometimes I remember those days in quietness and peace as it is after a hurricane and grateful to all people who gave me this chance of being in a great organization. (Picture 3)

It is our Scandinavian colleagues' time to take the stage now (Picture 4). I can imagine what they will go through. We wish them a good luck and energy.

The 20th annual WONCA EUROPE Congress in Istanbul has taken place during challenging times for EURIPA. The too early departure of Janko Kersnik and the change in the EURIPA presidency only a few month before the Istanbul conference demanded additional efforts of all members to represent EURIPA on the Congress. This Congress introduced some novelties, one of which was a symposium. After the resignation of Jose Lopez Abuin the Theme and the Title of the EURIPA symposium was changed to: "Poverty: A Treat And Challenge For Rural General Practice".

Christos Lionis, Jane Randall Smith, Jean Pierre Jaquet and Ferdinando Petrazzoulli actively participated in the Symposium. In addition to this Symposium, EURIPA presented it's past activities as well as its future plans during the Grand Session which was dedicated to all WONCA EUROPE Networks. EURIPA also held two workshops: "Modernizing Our Rural Practice: From Old Patterns Towards The Future"– Oleg Kravtchenko, Tanja Pakez-Pavlisko, Ferdinando Petrazzuoli, Jean-Pierre Jaguet - and "Tips on Managing Students in Your Rural Practice" which was headed by Christos Lionis. As a co-author we miss Janko Kersnik.

David Schmitz, as a representative of the Wonca Working Party on Rural Practice held a workshop: "Rural Proofing for Health Policy: Use of a Rural Lens – an update from the WONCA Working Party on Rural Practice".

EURIPA members were also very active on a number of other workshops during the Congress as well as in acquiring new contacts and upholding the old ones.

The EURIPA booth had a lot of visits and there was a raffle to promote the 6<sup>th</sup> EURIPA Rural Health Forum in Marseille in 2016.

As some members of the EURIPA's Executive Committee and IAB were not able to attend due to their tight schedules, those present carried out many activities to represent EURIPA and the next Forum in Marseille, which was presented in a plenary session.

During the Congress, the EURIPA AGM was held and Tanja Pekez-Pavlisko was elected as the new President of EURIPA, Oleg V. Kravtchenko remains vice-chair. Newly elected members are David Halata, Veronika Rasic (as a representative of VdG) and Josep Vidal-Alaball who was also elected as treasurer. Members of the executive Board thanked Raquel Gomez Bravo on her great contribution to EURIPA.

The WONCA Europe Council meeting was also held before the Congress at which Tanja Pekez-Pavlisko once again mentioned dissatisfaction of EURIPA members on the fact that EURIPA does not have a representative in the Executive.

The traditional Rural Dinner was held in a cozy restaurant in the heart of Istanbul; with thanks to Nick Randall-Smith for his excellent recommendation and organization.

Last but not least, we would like to thank Prof. Dr. Dilek Guldal on the excellent organisation of the Congress.

### **Reports from EURIPA members**

## Chronic Morbidity - recognition for EURIPA researcher

During this year EURIPA has undertaken a piece of work focussing on Chronic Morbidity and the problems encountered by general practitioners in rural areas. Initially a small working group was set up and a questionnaire developed. The initial outcomes were presented in a workshop at the WONCA World Rural Health conference in Dubrovnik.

Full analysis of the data collected then took place and the project was written up. The project was very much a partnership project. Supervision was by Jean Pierre Jacquet, who is now chair of the International Advisory Board, and his student Jean Baptiste Kern led on the project and submitted it for his thesis. Other partners included Donata Kurpass, Dominik Marciniak, Candan Kendir, Dilek Guldal and Jane Randall-Smith. All the partners, from France, Poland Turkey and the UK, worked as a team so it was a real EURIPA effort!

# The Rural Family Medicine Café – International Collaboration via Social Media

A few months ago Mayara Floss, a medical student from Brazil, came forward with the idea of initiating an informal online meeting – the Rural Family Medicine Café. The first Rural Medicine Café was held in October with the help of Sarah and Roger Strasser, Amber Wheatley and myself. The purpose of this Café is to bring together people interested in rural medicine and provide an opportunity for them to discuss different topics, issues and ideas relevant to rural health. As the café is broadcast online via Google hangouts and later available for viewing on YouTube it provides a valuable opportunity to share information with a wide audience.

In the three Rural Cafés that have been held so far we have discussed the state of rural health in different countries, how to involve medical students in rural practice, outcomes form WONCA conferences, the use of social media, inequity and more. Our guests have been form Brazil, Canada, British Virgin Islands, India, Australia, Portugal, Spain, Egypt, Croatia, and we look forward to gaining insights from many more countries.

Many students and junior doctors who may be considering (of find themselves) working in a rural area do not know where to start looking for information about this career option. The Café acts as a place to find answers and ask questions as well as making rural medicine more visible. It also provides a way to reduce potential feelings of isolation as often rural practitioners work in solo practices and may not have many opportunities to meet with colleagues. Through our discussions we have found that rural practitioners everywhere face many of the same problems. Anyone can actively participate in the Café, either as a guest on the Google hangout, or by joining the discussion on Twitter and Facebook.

Beyond Europe Liaison at Vasco da Gama Movement Member of EURIPA Executive .....

EURIPA's new Executive Committee member, Jose Vidal ALaball, is interested in the application of new technologies in rural practice and he participated in a workshop on this in Istanbul:

### **Teledermatology - Wonca Europe 2015**

Teledermatology is an increasingly common activity in the Spanish primary care as Dr Josep Vidal-Alaball explained at the WONCA Europe Conference held in Istanbul. He exposed his experience using this tool in a primary care team in rural Catalonia.

Telemedicine is a tool that has proven effective and efficient improving patient access to health services, said Dr. Vidal- Alaball. Furthermore as has been demonstrated in the Catalonian Central Region, it serves to reduce waiting lists (Vidal-Alaball, J. et al., 2014. Assessing the impact of teledermatology in reducing the waiting list in the region of Bages (2009-2012). Aten Primaria, pp.9-10.).

In rural areas teledermatology is especially interesting because it avoids long journeys for users to the hospital. Dr. Vidal-Alaball explained that some patients were suspicious about teledermatology at the beginning, but now they have seen their advantages of the system and they are often asking themselves to the doctors to send a photo to the dermatologist to avoid travelling to the local hospital.

During the discussion that followed the presentation of Dr. Vidal-Alaball attendees were interested in the details of the teledermatology program. They asked for issues around the confidentiality of the images and the legal aspects of telemedicine. Dr. Vidal-Alaball explained that the confidentiality of the images is guaranteed at all times because they are embedded in the electronic patient clinical notes and do not travel over the network at any time. It is the dermatologist who enters medical history, review the images, makes a diagnosis and proposes treatment.

# Looking forward to 2016

In 2015 EURIPA participated in the 13th WONCA World Rural Health Conference in Dubrovnik in April and as a result did not hold an event of its own. However, plans are now well advanced for the EURIPA 6<sup>th</sup> Rural Health Forum which will take place in September 2016:

# My practice

# David Halata, our new Executive Committee member, writes from the Czech Republic:

I work as an independent contractor providing practice health care in rural practice in community Hošťálková with the population of 2.500 inhabitants, situated in the east of the Czech Republic, located into the middle of Wallachian highlands. The time of transfer to the nearest rapid hospital is 20 minutes by car but in winter (with snow cover on roads) is definitely longer. A great number of patient's habitations is spread around the hills with worse accessibility. 2.100 patients are registrered with my practice. Together with me in the village works a paediatrician and also a dentist.





I continue in my father's work, who was also a family doctor for 43 years in our village.

In my practice I work in the primary healthcare team with two practice nurses. Working hours are 30 hours a week. After opening hours follows visiting service of patients at home and then administration activity in the doctors office. In addition to that, on average we treat 40-50 patients daily. In out-of working hours is medical care centrally ensured by emergency medical service, but nevertheles the rural GP provides this care service to his patients too. Provided medical care is covered by health insurance companies on the base of self contractor.

Documentation of patients is kept in electronical version. Our practice is equipped with ecg, 24-hour blood pressure monitoring , point of care testing CRP, HbA1c (glycated hemoglobin), INR (protrombin time) and ABI (ancle brachial index) measurement system. We provide dispensation to patients with hypertension, dyslipidemia and diabetes mellitus type 2 with peroral antidiabetics (prescription of insulin is not in a competence of GP in Czech Republic). Furthermore we provide all blood counts and re-bandages of injures. With regard to worse accessibility of special care, we also provide small surgery, solution of the basic oftal and ORL cases and last but not least, emergency care (Advance Life Support).

All in all, work of a rural GP is strongly connected with the community in which he has lived. On one side, it is time consuming, but on the other side, more comprehensive, demanding a good knowledge of environmental problems with the influence on patients' health and trying to find the most effective solutions with respect to living beings and environment. Let alone the fact, that rural GP is often pressed under special circumstances to work on the edge of his professional competences.
